The meeting opened at 7:05 p.m. with a prayer.

School Advisory Report Given By Diane Vigneron:

- · Looking for a tuition management company
 - o Starting exploring this option per the Archdiocese
 - o They will handle the collection of the tuition-parents will pay the company so that the payments are not going through the school secretary
 - o If the families pay upfront they will not have to go through the company, they will pay IC directly
 - o Trying to see which program best fits IC and who is set-up to handle service credits, script, etc.
 - o They have looked at two companies: Christian Financial Credit Union and FACTS
 - Christian Financial CU is a bank and the money will go directly to them, but they do not specialize in collection
 - FACTS is a company that solely handles this type of work. They are more aggressive at collecting the money. They charge \$45 a family (173 families) and they will be flexible for families.
 Families will be able to pay with credit card through the company which is not offered at IC.
 Parents at other Parishes like working with this company
- Horn of Plenty raised \$8K for athletic program
- Ladies Night Out surpassed their goals but exact figure was not given

Discussion occurred regarding the tuition collection. Andrea stated that she thought that the whole reason why they went with Vanco for the Parish collection was because they offered a tuition option. Father Tomek stated that they had a tuition option, but that company would not act as a collection agency rather as an intermediary for the school. Other discussion included whether there was a large need for a collection agency to handle payments and the question was asked if there is a lot of back tuition. Father Tomek stated that there was a need for the collection and that if the tuition was taken out of the accounts just like a mortgage or car, that it would be paid. The company will also be taking the burden of "reminding" the parents that the tuition is due and/or late.

Christian Formation Report Given By Jane Petitpren:

Evangelization Given By Deacon Ken: No Report

Vicariate Report Given By Amy O'Gara:

- Discussion about Drift-change possibly to a monthly and one pager rather than the three pager
- Looking for a second Vicariate Rep- Father Tomek stated that he is looking for candidates, he wants to be able to involve more people
- Meetings are held at Holy Family in Memphis

Old Business:

- Issue of Minutes and Commission Reports given to Secretary in timely manner: Have minutes prior so that we can have questions ready prior to the meeting. JoAnn stated that this would not be possible for CS because they often have the meetings the same day as the Parish Council, which would be ok. Sue stated that she thought that there should be a time limit on the commissions rather than having the minutes sent prior. She stated that then the committee members would just come to sit rather than give the reports. Andrea stated that this would allow everyone to be able to review the reports and that this would allow us to have questions ready rather than trying to digest all of the information in a short amount of time. Amy stated that she would like to see the reports ahead of time. Andrea stated that she preferred the information for the minutes and reports no later than the Thursday prior to the Parish council meeting so that she has time to compile everything because she has to place some of the minutes in the regular mail and they need to get to the Council Members on time.
- Father Tomek's request for Parish Council Members to address Parish: wanted to know what they would be addressing the Parish about. Father stated that it would be about what the Council is doing for the year, CSA, Phase II, present plan to the Parish for Long Term Planning-these presentations will not be done until next fiscal year, because there is nothing to present at this time. At some point Father would like to see this done at the beginning and ending of every year.
- Calendar: committee had Calendars out in a timely manner

New Business:

- 2010 Festival Committee first meeting Feb. 25th @ 6:30 pm in Parish Hall w/ Pot Luck
- CSA in bulletin-Pam requested to start moving with CSA-Stewardship has a sub-committee to handle this-Father Tomek stated that we had to do some kind of follow-up and that it may take a whole new approach,
- Discussion regarding active members in the Parish- the Long Term Planning did a survey and they received 78% response (but this was done 3-5 years ago), need to put in the bulletin that after 18 (or another age) that the individual should be registered in the Parish if they want to be recognized on their own (i.e. for marriage, etc)-Father Tomek again stressed the need to have policies worked on and put them in writing and revised (the only one currently being revised in the Weddings & Funeral policy) –we should look at examples from other Parishes
- Dec 29th Christmas collection that were done through e-giving were not included in totals yet-to be shown sometime in January
- Heating in the Church-working on it, new boiler so it is being adjusted

Open Forum:

• Tim stated that he would like to see the Parish move forward on a Pro Life Group to foster Pro Life activities in the Parish-Deacon Ken stated that the meeting he had was an informal meeting and that he would be discussing with Father as to whether this is something that the Parish wants to have. Father Tomek stated that this would be a part of the Christian Worship, Services, or, Formation and that there needs to be a plan in place before this can continue.

Pastor's Report:

- Christmas went well-decorations were out (saved money on) and they were beautiful, Celebration of
 Eucharist attendance was good, had a lot of guests and thanked Parishioners for bringing them music was
 outstanding
- Bank Closure:
 - o Didn't have a lot of time (45 days) to move accounts
 - Vanco stated no problem with transferring to the new account
 - o Kimberly made a lot of calls and spent two full days to take care of opening new accounts
 - O Had a few leads and had people who helped by giving him guidance
 - Looked at 4-5 banks:
 - 5/3: closest, offered room for collection cash to be counted, but they had a lot of hidden fees and the fees were too high, they also charged for depositing a certain amount of cash
 - Also looked at Comerica & Huntington
 - Charter One (the one IC chose): They already work with other Parishes in Diocese, they were honest and upfront regarding fees, they stated that they would be willing to work with IC, the only downside is that the deposits would have to be driven to the branch location (discussed safety of this) and that the Parish would be looking at armored car service (had one family offer to donate ½ of the cost)
 - o Children at the school wrote thank you notes to the employees at the Bank
 - Few people approached Father to purchase the property because it was part of the original long term plan
 - Father Tomek didn't know if it was for sale yet and didn't think it would be for sale any time soon
 - Don't know the price and the Parish currently does not have the money for it
